FIELD NOTE DESCRIPTION

12.364 ACRES

THENCE; N 63° 08' 00" E, with the Northwest line of the 21.94 acre tract, the Southeast line of the 57.10 acre tract and Southeast margin of the county road 60.47 feet to a 1/2" iron rod w/cap set.

THENCE; In a southerly direction parallel with and 60.00 feet Easterly of and at a right angle to the West line of said 21.94 acre tract as follows:

S 17° 45' 06" E, 160.02 feet to a 1/2" iron rod w/cap set.
